

**Never place any wireless device in direct contact with your body,
not even your cell phone!**

The "PhoneGate" Scandal

By law, the cell phone manufacturers are *not required* to test their phones for compliance with the regulations on maximum microwave radiation exposure limits set by government agencies – such as the FCC in the United States – in the manner in which phones are actually being used by the consumer: In direct contact with the body.

Instead, they are allowed to test their phones at distances up to one inch away from the body for compliance with the FCC's [SAR](#) limits. The exact distance for each phone model is usually hidden in the fine print somewhere on the back pages of the user manual.

The "PhoneGate" Scandal broke in the European media in 2017.

The American media kept silent.

The National Frequency Agency (ANFR) of France (the French FCC) disclosed in 2017 that **most cell phones exceed government radiation limits when tested the way they are used, next to the body.** Their SAR radiation measurements tests **at body contact** revealed that in 2015, **9 out of 10 phones** exceeded regulatory limits up to 9 times (by European safety standards), and at least **up to 11 times by US and Canadian safety standards!**

On their website, EHT provides detailed information about "PhoneGate", and a downloadable PDF of the ANFR cell phone test measurement data of nearly 400 mobile phones in English, together with a (conservative) estimation of the French results when converted to the much stricter US/Canada SAR limits.

Aside from the fact that the SAR limits are set ridiculously high to begin with – only accounting for thermal damage of the RF/microwave radiation to living tissue (that effect is used in the microwave oven, by the way) – by using parameters that have nothing to do with real usage, manufacturers have knowingly misled consumers about the *real* SAR levels of their mobile phones ever since the beginning of the "cell phone age" in 1996. **The magnitude of the fraud and deception perpetrated upon the public by both the telecommunications industry and government agencies worldwide is beyond compare.**

The phone is always emitting radiation (unless in Airplane Mode)!

Most of the general public is unaware that **their phone is *always* emitting radiation**, even when they are not using it. Unless put in Airplane Mode, the phone is constantly checking in with the nearest cell tower to maintain the network connection, ready to receive the next call, text message, or other notification. In addition, any running apps are communicating in the background, and widgets are constantly syncing.

Protect yourself!

If you absolutely must use a mobile phone, take steps to protect yourself by **keeping it away from your body**. Do not carry it directly on your body, unless placed in Airplane Mode, and use it only on **speaker phone**, or with an **Air Tube Headset** that will not transmit the radiation directly into your brain (as normal headphones do).

Microwave radiation: A new serious form of Environmental Pollution

The RF/microwave radiation emitted by **all** wireless devices is completely alien to life on Earth. Our planet is exposed to nearly no radiation in this range of the electromagnetic spectrum, so life on Earth never had to evolve any defenses against it. (If Neil Armstrong had brought a cell phone to the moon in 1969, it would have appeared from Earth to be by far the brightest object in the universe in the microwave spectrum, outshining every star.)

In response to dozens of scientific studies demonstrating its harmful effects on *all* life, the World Health Organization finally classified radiofrequency/microwave radiation as a Group 2B carcinogen in 2011. However aside from the necessity to stop poisoning ourselves with it, it is high time we face the fact that **saturation of the environment with this type of foreign radiation constitutes a form of environmental pollution no less serious than releasing toxic chemicals into the air, ground, or water!**

Because of its indiscriminate worldwide proliferation, the cell phone is the most aggressive piece of technology we have ever invented. In order for the cell phones everywhere to work, their entire wireless infrastructure with millions of cell towers and antenna stations has to be there, all over the planet. Consequently, RF/microwave radiation is the first pollutant in history that is being *deliberately spread all over the Earth*, not just with the goal of leaving no place unpolluted, but also *with absolutely no regard* to what this might do to our fragile biosphere and all our fellow creatures within it!

In view of this, please consider: If you use a mobile phone (or any other wireless device), you not only irradiate yourself with high levels of this foreign radiation, you are also placing every living being around you at risk. The microwave radiation travels in all directions and goes on, as long as there are no objects in the way that can stop it. When you are making a call, you are polluting your own and at least one other person's neighborhood, because the nearest cell

tower has to turn on a voice channel just for you, which then broadcasts the microwave radiation at even higher powers in every direction out into the landscape and the atmosphere. If you have a smart phone and use the Internet, the cell tower also opens up a data channel just for you and starts broadcasting even more radiation at additional microwave frequencies and pulse rates. And in order for you to reach the person you are calling, their nearest cell tower also has to open up a channel just for them and send radiation in all directions, and that person has to answer their phone and irradiate themselves and their own surroundings.

And what's even worse: Every time you use your phone, you are demanding service. Now when you try to place a call in a remote location where cell phone service is poor or non-existent – meaning **that area is still largely free of microwave pollution** – your provider registers that as a "request for service". If it gets enough requests for service in that location, it will build a cell tower there. As a result, cell towers are now spreading into Wildlife Refuges, and even National Parks. What that might mean to the wildlife in those areas is for example illustrated in the following alarming document:

70 to 90% of the wildlife species have disappeared from the Mt. Nardi area of the Nightcap National Park in Australia
